Precautions in connection with Fire

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers. Fight fire from safe location. This product should be prevented from entering drains and watercourses.

Section 6 - Accidental Release Measures

Emergency Procedures

Remove all sources of ignition. Increase ventilation. Evacuate all unprotected personnel. Do not breathe loose fibre. Wear respiratory protection and full protective clothing to minimise exposure. Sweep up material avoiding loose fibre generation - dampen spilled material with water if suitable to avoid airborne loose fibre, OR where possible use dustless methods such as vacuum to collect the material; then transfer material in to suitable vapour tight labelled containers for subsequent recycling or disposal. Dispose of waste according to applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

Section 7 - Handling and Storage

Precautions for Safe Handling

Avoid inhalation of loose fibre, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of loose fibre in the work atmosphere. Establish good housekeeping practices. Remove loose-fibre accumulations on a regular basis by vacuuming or gentle sweeping to avoid creating loose fibre. Maintain high standards of personal hygiene i.e. washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a well ventilated area away from heat and sources of ignition, out of direct sunlight and moisture. Take precautions against static electricity discharges. Use proper grounding procedures. Store away from incompatible materials such as materials that support combustion (oxidising materials). Store in suitable, labelled containers. Inspect periodically for deficiencies such as damage or leaks. Have appropriate fire extinguishers available in and near the storage area. Ensure that storage conditions comply with applicable local and national regulations.

Engineering Controls
